### NYS Boater Safety Course - Monday, April 25 & Tuesday, April 26 5:30pm-9:30pm

Instructor: Allan Miller

This is a comprehensive boating safety course, teaching the fundamentals of safe boat operation. Anyone operating a personal watercraft in New York State is required to have this training. Independent operation of a motor boat for anyone older than 10 and under 18 years old requires a NYS Boater Safety Certification. All individuals born on or after 5/1/96 are now required to successfully complete an approved course in boater education in order to operate a motorboat.

Upon completion of this class, those under 18 years of age will receive a NYS Boater Safety Certificate. Those over 18 may apply to NYS Parks for their certificate.

### Flag Etiquette STANDARDS of RESPECT



I was driving around the lake one day and was amazed and gratified to see our flag flying from so many homes. I noticed one was rather ragged and recalled reading many years ago about how to show respect for the U.S. flag. I did a

little googling and found the following. I was surprised at how misused this symbol of our country is and wanted to pass this information along to you. I think you will be surprised as well. —Sharon

The Flag Code, which formalizes and unifies the traditional ways in which we give respect to the flag, also contains specific instructions on **how the flag is not to be used**. They are:

- The flag should not be used as a drapery, or for covering a speakers desk, draping a platform, or for any decoration in general. Bunting of blue, white and red stripes is available for these purposes. The blue stripe of the bunting should be on the top.
- The flag should never be used for any advertising purpose. It should not be embroidered, printed or otherwise impressed on such articles as cushions, handkerchiefs, napkins, boxes, or anything intended to be discarded after temporary use. Advertising signs should not be attached to the staff or halyard. This one really got me. It's all you see around the 4th of July.
- The flag should not be used as part of a costume or athletic uniform, except that a flag patch may be used on the uniform of military personnel, fireman, policeman and members of patriotic organizations.
- The flag should never have placed on it, or attached to it, any mark, insignia, letter, word, number, figure, or drawing of any kind. The flag should never be used as a receptacle for receiving, holding, carrying, or delivering anything. When the flag is lowered, no part of it should touch the ground or any other object; it should be received by waiting hands and arms. To store the flag it should be folded neatly and ceremoniously.
- The flag should be cleaned and mended when necessary.
   When a flag is so worn it is no longer fit to serve as a symbol of our country, it should be destroyed by burning in a dignified manner.

#### Update on Cedar Bluff/Wright Road/ Hill Road Project

A Town of Saratoga Planning Board workshop took place on February 10 to discuss a proposed development to build 34+ home on 113 acres, along Co. Rt. 71, Wright Road, and Hill Road in the Saratoga Lake area.

Developer John Witt made a presentation providing further updates of the plan, and some photos of the area and existing homes. His presentation highlighted his desire to clear for views of the lake and make the properties as attractive as possible.

Residents asked questions and made several very thoughtful and researched presentations about their concerns: Open Space preservation, Water Quality, Erosion, Traffic, Density and Suburbanization in our Rural town. Residents stated they believe that existing Town Regulations would not allow for this development in its current formation. They also said they are extremely worried about Mr. Witt's track record of clear cutting in areas where he does not have permission, and has received little or no penalty (case in the Town of Greenfield).

They urged the Planning Board to keep close watch on this. The Planning Board pointed out that the questions and concerns would be addressed as the project moved through various iterations, with studies etc.

Although the Planning Board was not in a position to vote at that meeting, there was support for keeping the culde-sac at the end of Hill road, and avoiding a through street as previously proposed by Mr. Witt. The Town Code Enforcement Officer also asked Mr. Witt to publicly agree not to do any clearing until subdivision approval. Mr. Witt hesitated, but agreed. We will have to watch this space.

The use of the open space as an agricultural lot and definition of the Conservation subdivision was discussed again. Residents were happy to have this opportunity to have their opinions heard at an earlier stage than a public meeting which could be months down the line.

Residents are encouraged to continue to participate in this process if we want a good outcome. (submitted by Maribeth Macica)

State cash boosts Lake George study
Effort to gather data on problems gets \$500,000 grant

The state is kicking in a half-million dollars to complete the Jefferson Project, a multimillion dollar environmental research effort aimed at making Lake George the most measured and best understood body of water on the planet.

On Monday, Gov. Andrew Cuomo announced that the project, launched in 2013 by Rensselaer Polytechnic Institute, IBM and the conservation group Fund for Lake George, will get funding through the Higher Education Capital Matching Grant Program.....

To qualify for the state grant, RPI, IBM, and the Fund for Lake George pledged \$1.5 million.

Twenty of the project's planned 41 high-tech lake and weather sensors are already in place, and the new funding should allow remaining sensors to be purchased and installed by the end of the year, Relyea said.

Lake, stream and weather data drawn from the current sensor network is being analyzed and converted into graphic displays at RPI's Darrin Freshwater Institute in Bolton Landing to explain how the 32-mile lake behaves and how it might change if some troubling trends continue.

The Bolton center is linked to an IBM supercomputer in Fishkill, Dutchess County, that can perform 188 trillion operations per second as it tracks a steady stream of data coming in from the sensor network. The center also has its own high-speed computer, and is linked to a third computer at the RPI Technology Park in Troy.

That data will create a picture of how weather, water that flows into the lake from about 140 feeder streams and the aquatic life all interact......

During summer 2014, the project produced a high-resolution, 3-D map of the lake bottom and the surrounding mountains. The map covers an area of about 230 square miles. By comparison, the city of Albany is 22 square miles.

Research from the projects is expected to eventually help create solutions to rising threats to the lake stemming from human activity, like the introduction of invasive species carried on boats, buildup of algae fueled by lawn fertilizers or sewage, and saltier water caused by the runoff of road salt.

Over the last three decades, salt levels in the lake have nearly tripled and the amount of algae has increased by more than 30 percent. If those numbers continue and lake water clouds, the lake's \$1 billion tourism industry and its valuable real estate market could suffer.

The Jefferson Project's assets stretch south to the Capital Region. At a lab at Rensselaer Technology Park on Route 4, Relyea has created a kind of mini Lake George, with 900 water tanks, each containing about 300 gallons, that run simulations on lake water.

### Saratoga County town rezones corridor to attract restaurants, hotels and offices

The Malta town board voted Monday to rezone parts of Route 9 and 67 to encourage investors, restaurant operators and others to invest in the growing Saratoga County community.

"What we want the development community to take away from this is that the town of Malta is open for business," said board member Timothy Dunn.

He is one of three new board members who took office January

1. The others are board members Craig Warner and supervisor

Vincent DeLucia.

Rezoning a 1.5-mile section of Routes 9 and 67 will allow the construction of hotels, restaurants, retail shops, brewpubs, fitness centers and other commercial projects in areas that had been restricted to residential development.

Town building and planning director Tony Tozzi said last month that property in the southern section of the town was not marketable under the previous zoning.

Ralph Passonno Jr., president of Uncle Sam Auctions in Troy, can attest to that. He has been trying to attract a buyer for the former My Way Café restaurant, which closed in the summer of 2011. The lack of municipal water and residential zoning made it difficult to find a buyer, Passonno said.

Now that zoning will accommodate more commercial uses, Dunn said that he is optimistic that a developer will come along and help extend water lines to service that area.

Malta has grown rapidly over the last 15 years. The population has increased by 14 percent to 14,875 people, and the number of well-paying jobs has grown since GlobalFoundries began building its \$12 billion computer chip factory that has created 2,900 jobs since 2009.

The town board also took steps to increase lot sizes and set back requirements in part of a rural section of town known as Maltaville. Dunn said those changes will help preserve the rural character of the hamlet.



#### What it Takes to Purchase Fire Apparatus

We would like to offer a little insight into the operations of the fire district such as ours. We just went through an extensive process to purchase a new fire truck to replace a unit that was purchased in 1995. It seems impossible that 21 years have



passed since the purchase of the current engine tanker. First let me explain that an engine tanker is designated as such since it has a rated pumping capacity of 1000 gallons per minute and carries 1250 gallons of water. Some engines carry as little as 500 gallons of water but since a significant portion of our fire district has no municipal water system, we need to carry water with us. Each of our four pumpers strategically located in the town carry 1250 gallons of water for a total of 5,000 gallons. While this might seem like a lot, the average back yard pool contains much more. We have to strike a balance between carrying water and how large we want our trucks to be; given some of the secondary roads in the town. Larger trucks take longer to fill and can slow down the water shuttle process. Our tactics are based on the ability to fill and empty trucks as quickly as possible, to reduce the shuttle turnaround time where no municipal water is available. The ideal situation is to never run out of water at the scene of a fire, even when no hydrants are available.

The strategy is to receive the call early enough and to reach the building soon enough and to be aggressive enough to control the fire with as little water as possible. Thus the importance of early warning smoke detection and the installation of sprinklers. Unfortunately we are starting to lose the battle since homes burn so much faster and destroyed so much faster than 20 years ago. Some of the contributing factors are lightweight construction systems, petroleum based plastic contents and furniture plus open space designs. If we receive the call quickly, respond quickly and apply water quickly, we use less water and 1250 gallons may be enough. If not 12,500 gallons won't be enough. Again let me draw a comparison, a residential sprinkler head will darken a fire with 16 gallons per minute, a single fire hose will apply 260+ gallons per minute. Which causes more water damage?

Our process to purchase a new engine-tanker began a year ago. The first step is to perform an internal needs assessment, reviewing the needs of the fire department, the community and applying a number of assessment factors. Our planning team included the 9 line officers as well as members of the Board of Fire Commissioners.

Upon coming to agreement as to our needs, we drafted a concept of the apparatus and equipment to fulfill those needs. The planning team worked through the design criteria for several months until there was a consensus of need. The team then worked through a performance specification for the truck. A performance specification spells out what the department wants the truck to do and how to do it, but without specific design criteria, we would leave that to the manufacturers.

Once the specifications are agreed to, the planning team makes a recommendation to the Board, allowing the Board to make any suggestions or modifications. The specifications are then legally published for bid. Manufacturers pick up the specifications and were given 60 days to submit bids for the apparatus. Once the bids were opened, they were arduously compared using a matrix based on the District's performance specifications. The manufacturer's specifications are meticulously reviewed and are usually over 100 pages in length. Once the comparison matrix is completed a final recommendation is developed using the findings in the matrix, noting non compliance items or items that lack specificity based on the specifications written by the planning team. The Board then considers the comparison and decides on the manufacturer to award the bid to.

Our new apparatus will cost approximately \$530,000 and will last another 20+ years. Funding comes from a legally established capital reserve fund specifically established to be used to purchase apparatus for the fire district. We budget funds annually for this reserve account based on the long term apparatus replacement plan.

The new apparatus is custom built from the wheels up and will not be completed until spring of 2017, after another complete budget cycle. Some of the main features of the truck will be a 1500 gallon per minute pump, 1250 gallons of water, the capability of producing foam through several hand lines to enhance extinguishment, a 1500 gallon portable pond used where water has to be shuttled from a water source to the fire scene, 1000 feet of 5" large diameter supply line, four fire attack lines, quick dump chutes to quickly dump water into the portable pond, the capability to carry a crew of 5 firefighters and a myriad of other tools and equipment.

What happens to the old truck? When the time comes the fire district will sell the used truck which will be worth approximately \$45,000, usually through a used fire apparatus broker. The money realized from the sale will go back into the capital reserve fund for fire apparatus and process begins again. We have sold trucks to departments in North Carolina and Pennsylvania. The next truck to be replaced was purchased in 1998, 18 years ago.
