

Adopt-A-Highway Program



Across the country, thousands of communities have signaled their commitment to keeping America beautiful by adopting stretches of highway and pledging to keep them litter-free. The Adopt a Highway program offers both organizations and volunteer

groups the opportunity to contribute to their community; promoting community pride and a means of publicly recognizing group efforts.

The State of Texas had begun an experimental program, a unique partnership in which everyone benefitted. Through the "Don't Mess With Texas " Program, organizations and individuals volunteered to adopt sections of Texas highways and to remove roadside litter. What had begun as a county-wide experiment grew into a national model. Legislation to formalize New York State's Adopt-A-Highway Program was passed in 1990 to encourage individuals or groups to clean up highway roadsides and to recognize those volunteers who do.

Today, all 50 states have some type of a sponsor-ahighway or adopt-a-highway program in place because there is a very real human need for aesthetically pleasing roadsides in spite of the reality that highway beautification simply cannot compete on an even level with highway safety for ever-diminishing public funds.

The debris from the summer has accumulated along Route 9P; before leaves fall covering the debris up... Please consider contributing some of your time and energy to assist in this year's Annual Fall Season "Adopt a Highway" Roadside Clean-up effort, which is scheduled for Saturday, October 11, 2014.

The racing began in Albany at the Head of the Hudson regatta... after fighting high winds and whitecaps for the 3rd year in a row, we are reminded of how blessed we are in

– A dump truck laden with used blacktop struck a pickup truck and two other cars in an accident at the intersection of on Route 9P and Plains Road Wednesday afternoon. There were no major injuries, State Police said.

Mark D. Pritchard, 42, of Albany, was driving the dump truck on Plains Road when he failed to stop at the stop sign at Route 9P, troopers said. Pritchard struck two pickup trucks as he entered the intersection, one headed north on Route 9P and another headed south.

The northbound pickup truck overturned and struck another southbound vehicle, police said. The pickup truck driver was taken to a hospital for minor injuries. The driver of the other car was uninjured.

The southbound pickup truck was forced into the parking lot of South Shore Marina where it was crushed by the dump truck, troopers said. Both drivers were uninjured.

The dump truck is owned by Morgan Paving, based in Stillwater, and is being inspected for any mechanical failures that may have lead to the collision, police said. The Saratoga County Sheriff's Office, Department of Environmental Conservation, Roberts Towing and Recovery and Malta fire police, fire department and EMS assisted at the scene.

Dog Licensing is Vital to Public Health

To protect public health and ensure compliance with state law, we urge all dog owners to license their dog. In issuing the license, Flo Sickels, Malta Town Clerk, will work with you to ensure that your dog has been vaccinated for rabies.

Rabies is a disease caused by a virus that attacks the central nervous system (brain and spinal cord). It can be transmitted to humans who have been bitten by a rabid dog or other animal such as a cat, fox, or bat. Once clinical signs of rabies appear, the disease is nearly always fatal.

Licensing is vitally important to finding and quarantining dogs that mayt have bitten a person. Lacking knowledge of the dog's vaccination history, peoOple bitten may have to undergo a risky and expensive rabies prevention treatment.

A side benefit to owners who love their dog is that licensing also makes it possible for our Animal Control Officer to reunite lost dogs with their owner.

Dry Weather Brings Fire Danger

According to the US Drought monitor our area and the entire lower Hudson Valley and the Catskills is classified as being in the 1st stage of drought = Abnormally Dry.

Implications are; with the dry soils, dried vegetation and leaves falling off the trees places us in a higher risk of wildland fires. Please be very careful when performing burning outside. Douse any camp fires, do not leave fires unattended and for larger brush burns a permit is required.

Homeowners are responsible for their actions should a fire spread. A couple of factors that are in our favor is high humidity levels overnight and we are not seeing extremely low humidity levels during the day. Warm Greetings to Everyone!

The arrival of October places us in the final quarter of the year. Our energies are now divided between working on this year's business and making plans for next year. The next meeting of the Town Board is scheduled for Wednesday, October 15th at 7:00 p.m. Some of the items that will be covered at this meeting include: public hearing on the SRA Regatta, zoning officer's report, town clerk's report, supervisor's report, and court report. The Town Board Agenda meeting will be held on Thursday, October 9th at 7:00 pm. The town offices will be closed Monday, October 13th in observance of the Columbus Day Holiday.

2015 Town Budget

To date we have conducted two budget workshops as we put the 2015 budget together. We will be reviewing it closely for needed adjustments. We will be staying within the 1.56% Tax Cap limit suggested by the State of New York. Given certain increases in expenses over which the town has little control, such as insurance rate increases, state retirement contribution increases, salt increases, black top increases, this has proven to be a big challenge, We will continue to review the budget and will have a vote to adopt the budget on November 6th.

Town and SLPID Building Update

We are moving forward in our arrangements with SLPID for the building of a SLPID storage building on town land adjacent to the highway garage located on Route 32 south of the Village of Victory. The Town attorney is currently finishing the contract and it is expected that construction will start sometime later this fall.

2014 Women of Distinction Recognition

Senator Kathleen A. Marchione conducted an Awards Ceremony on September 24th to recognize 15 Women of Distinction from throughout her Senate District. Three individuals from within the Town of Saratoga were among those recognized. They included: Michelle Larkin for her leadership in Rebuilding Together, Margaret Kirkpatrick for her work in the Quaker Springs Fire Department, and Windy Lewitinn for her work at the Schuylerville Public



Gateway Regional Visitors Center

Progress continues to be made for the building of a Gateway Regional Visitors Center on the site of the old Town Hall at 30 Ferry Street in Schuylerville. At he Historic Hudson - Hoosic Partnership meeting on Monday the 29th of September the Town of Saratoga will be named the financial agent for the project. As the financial agent the town will manage all of the flow through money from the state for the construction of this project. Construction plans will be developed this winter and actual construction is expected next fall.

Underground Railroad Historical Marker

Under the leadership of Historian Sean Kelleher the Town of Saratoga is applying for a state historical marker to be located at the intersection of county routes 67 and 70 (Deans Corners) to designate a large meeting that occurred their promoting the release and freedom for all slaves in the United States. The Town of Saratoga played an important part in the underground railroad movement and it is important that this information be communicated to the public.

Saratoga Springs Waterfront Park Breaks Ground By Lauren Mineau Saratogian, September 22, 2014

Shovel has finally met sand in the long awaited start of allowing public lake access in the city of Saratoga Springs.



Current council members and many members of past administrations officially broke ground on the Waterfront Park project Monday, which will provide additional public access to Saratoga Lake within city limits.....

.... In the early 2000's, city residents voted to pass a bond referendum that would allow the project to continue moving forward. The passing of this referendum allowed the city to purchase the land in 2006 for \$2 million, but it remained nearly untouched.

Mike Ingersoll of the LA Group worked to draw up a design for the property, keeping with the general theme of the 2006 master plan. The first phase of the project will begin at the water, by returning the lower terrace to a sand beach and create a space for picnicking and kayaking and restoring the water's edge.

A small amphitheater will be built on the middle tier of the land, ideally for gatherings of community events and the upper tier will be the main parking lot with a staircase town to the middle tier and the beach.

The plans for the park going forward are a modified version of the 2006 master plan. There are no plans for swimming at the new park yet.

"The hope is that next year or the year after, once the park operations are in place the picnic pavilions, bathrooms and other amenities can come into play," Ingersoll said.

The city will be reimbursed for two state grants, one at \$200,000 and another at \$350,000.

"What we needed to do was really show the state that we were doing something with the land that they could then reimburse us for. Without any invoices, without any contractor in hand, or work being done, we had nothing to submit to the state," Yepsen said.

With the ground breaking Monday, the city can now submit invoices to the state for reimbursement.

Before the city purchased the four-acre space, it served as a space for the seasonal Waterfront Restaurant from 1982 until its sale in 2005. Prior to that, it was known as Ryall's Beach House, a private bathhouse in the 1940's that was a popular summer hangout.

.....Alan Richer, president of the Saratoga Lake Association, said he's looking forward to being able to add the beach to Saratoga's arsenal of attractions.

"When you think of Saratoga, you think of horses and everything else. But in terms of being a diamond, this is something people don't always think about," he said.

We'd like to share this letter to the Saratogian Newspaper from Public Works Commissioner, Skip Scirocco, with our readers interested in the ongoing drinking water issues in the City of Saratoga Springs.

<u>Commissioner Scirocco Reader's View: Some clarity on</u> <u>Saratoga Springs' water supply</u>

A series of letters having to do with the adequacy of the city's water supply have been published in The Saratogian over the past few months and it has become difficult for readers who are not familiar with the issue to separate fact from fiction. As commissioner of Public Works, I thought I could shed some light on the subject.

Our city is fortunate to have a number of viable water sources. Bog Meadow and Geyser Crest are just two of them. Making the best use of our existing sources and developing new ones at the lowest cost to the rate payers makes the most sense. Contrary to James Sutherland's allegation that nothing has been done during the past 26 years and Pat Design's criticism, Wilma Koss was right in citing several improvements that have been made over the last several years to supplement and perhaps even to replace Loughberry Lake.

It's hard to know why Design attacked Koss' Reader's View or whether he even read it since he made so many mischaracterizations. It is especially difficult to know whether he understood James Sutherland's Reader's view. Mrs. Koss used the Sutherland test regarding Loughberry Lake for determining acceptability of a water source, and based on Sutherland's criteria, concluded that Saratoga Lake would not pass the test. Sutherland didn't discuss Saratoga Lake , but rather laid out several issues that make Loughberry questionable. Those same issues apply to Saratoga Lake.

In his haste to rehabilitate Sutherland, Design claims that Sutherland simply suggested that after 26 years we need to update the study. Design may not recall that Sutherland flatly said in his report 26 years ago that we would run out of water in 10 years and immediate action was needed. Sutherland himself acknowledged that his recommendation was "unrealistic" but attempted to provide an excuse why he made an unrealistic recommendation in what was supposed to be a scientific study. Design conveniently avoids that topic.

Finally, Design lays out some worst-case scenarios and dire consequences, not unlike the rhetoric we heard during the prior Public Works administration and continue to hear from the former commissioner and the former director of *continued* Public Works. Design makes no attempt to support his conclusions about the volume of water that could be supplied by the aquifer in the Bog Meadow. He has no studies to refute the engineering reports I have, which draw quite different conclusions and were not fully explored during the last administration. Design has no basis for even suggesting that the water from the Bog Meadow could be incompatible with the water in Loughberry Lake, nor is it relevant since the water from the wells can go directly to the treatment plant.

I take very seriously the responsibility to make sure we have an adequate supply of quality drinking water for the city. But even though we can easily meet our demand for water, we are always seeking ways to improve the system while keeping the cost of water low compared to the surrounding area.

From the Department of Transportation

When you gather leaves, weeds (lake weeds) and other lawn materials, DO NOT DEPOSIT IT IN THE DITCH LINES. This causes drainage problems. Some ditch line work was recently completed along Route 9P.

Problems that occur on private property that affect the state right of way, such as mud slides, water, ice fallen trees, could legally be enforced by the cost of repair falling to the landowner. Boats and docks stored on the right-of-way are considered a hazard and are illegal. Docks should be stored at least 15 feet from the road's edge. Fixed objects present safety issues for vehicles, including snowplows.

A driveway owner is responsible for maintaining his/her driveway beginning at the back edge of the shoulder pavement inclusive of removing snow from the end of his/her driveway. It is the responsibility of the driveway owner to remove enough of the snow banks as to allow anyone leaving the driveway the ability to see in both directions before entering the highway (9P). It is against Vehicle & Traffic Law to place it back onto Route 9P. If a person pushes it across Rt. 9P, it is their responsibility to clean snow that may be left on Route 9P.

The Arvin Hart Fire Company would again like to thank everyone for their donations during this year's fund drive. We have exceeded last year's monetary total even though only about 15% of the envelopes sent out were returned.

Fire prevention week is coming up and this year's theme is Working Smoke Alarms Save Lives, Test Yours Monthly. In an average fire, do you know how long it takes for your smoke detector to activate, under ideal conditions less than 30 seconds. The Arvin Hart Fire Co will try something different this year with an open house on Wednesday evening October 15th from 5pm to 8pm. This does a couple of things, changes the time so as to not take away from resident's weekend and is a regular training night for our members. We do hope that you would stop by and see us. It's very discouraging when our members try to put together a good program and no one cares enough to show up. After a while we feel that as long as we show up with the big red trucks, no one cares. Please just stop by for a few minutes at our main station on Campbell at Kellogg Roads.

Do you have any idea what the number one cause of residential fires is? Give up? Cooking fires! During a four year period ending in 2011 more than 150,000 home fires involving cooking equipment were reported causing over 400 annual deaths, 5,800 injuries and \$853 million in damages. What's really a shame is that they are easy to prevent, don't walk away with the stove on, keep a lid to smother fires if they do occur, and don't try to move a burning pan.

We have covered this subject before, house numbers. We responded to a call recently and were unable to find the correct address because the numbers on the mail box were unreadable as were the numbers on the house, the home owner had to walk up the street to find us. It's embarrassing to not be able to identify numbers but it's really not our fault. According to the International Fire Code house numbers should be at least 4" high and contrast with the background they are mounted on. Numbers on the front of a mail box are impossible to read, especially from a fire truck which is higher than the mail box. Small numbers over the garage door are impossible to read as are numbers that are written in script. Large numbers under the porch light are a good idea. The other thing that drives us nuts is no one flags us down, you respond to a call, everyone is outside to see what the commotion is but the residents where the call originated from just stand there. Please get excited wave your arms, jump up and down and at night wave your flashlight. Don't worry we won't have a problem finding your house if it's on fire, we just look for the smoke, but what if it's a CO detector or a medical call where time is of the essence. I know we are going to have to talk about this forever but please post a number large enough to be seen from space, well maybe just the road. Help us help you.

There are misconceptions about sprinkler systems, especially residential systems. On TV when a sprinkler system goes off, all the heads activate, very dramatic but not how it works. On TV the hero runs through the smoke and flame to rescue his true love, nope, not how it really is. On TV, firefighters go into a building without air packs on or coats buttoned, nope, doesn't work that way. On TV fires last forever and then go out all of a sudden, nope, no instant fire out switch. Residential sprinklers are part of the plumbing system and are designed to use minimal water to enable you to escape. When it reaches 155 degrees at the ceiling, a sprinkler head will activate, knocking down the fire, giving you a path to escape and limiting damage, usually in less than a minute. It's like having a fire department parked in your home.

Firefighting is a tough job and in your community all the members are volunteers. There are career fire fighters in Saratoga Springs, Troy, Albany, Watervliet, Cohoes, Green Island, Schenectady, Johnstown, Gloversville and Amsterdam. Volunteers are required to be trained are provided personal protective equipment, air packs, helmets, gloves and hoods

which cost about \$7,000 per firefighter. In career departments, in addition to the protective equipment there are salaries, benefits, and retirement costs which is a bulk of their budgets. Career departments are short staffed in an attempt to contain staff-



ing costs; volunteer departments are short staffed because few people have the inclination, time or passion to do the job for free. Firefighters are not invincible heroes, they get injured and they die. In 2013 there were 101 firefighter deaths and in 2012 there were 69,400 injuries in the line of duty. If you are a career firefighter it's your job, if you are a volunteer it may interfere with your job. Wonder why it's hard to entice volunteers but if we had to pay for firefighters our budget would likely increase 10 fold. It's inevitable that some day we may have to entice members with pay because we have fewer volunteers and those we do have are aging out. Think about it! Want to keep your taxes down, think about volunteering it's more exciting than a roller coaster ride.

If you would like to pay your respects to fallen firefighters, the New York State Memorial Service will be held on Tuesday October 7th at 11:00am at the Empire State Plaza in Albany. Nine names of fire fighters who died in the line of duty will be added to the memorial wall this year for a total of 2,390 names dating back to 1811.
